## East Central Ontario Regional Council (E.C.O.R.C.) Report 2023

As in every other organization that operates mainly on donated time, volunteers are always welcome on board. The process begins by filling out the "Expression of Interest' form on ECORC's website. This is where your skills and interests will be matched up with available positions.

Remit 1 was introduced at an April zoom meeting. It was authorized by the 44<sup>th</sup> General Council. A long history of colonialization, which included residential schools, was forced on our Indigenous churches by the United Church of Canada in 1925 with church union. This remit is a way forward towards positive relationships and partnerships as represented in the 2 row Wampum Belt. A covenant between two peoples going down the same road in our own canoes. Two peoples respecting each other's travel, not paddling for the other.

To date, there are 66+ Indigenous communities of faith with 1,000+ worshippers covering diverse and overlapping tribes, nations, communities, clans and languages.

At the Spring meeting in May, in Cobourg, Kevin Fitzpatrick (Dunsford U.C.) and Kaitlyn Ostrander were ordained.

At the Fall meeting in Odessa, in October, Morgan Bell (Mt. Horeb) was ordained.

The Spring 2024 meeting will be held at Cambridge St. U.C., Lindsay on April 19 & 20.

# Affirming Committee 2023 Report

2023 was another great year for the Greenbank United Church Affirming committee, as we completed our second full year as an affirming community of faith.

In January, the Affirming committee learned that North Durham Pride and the Scugog of Chamber of Commerce were committed to growing the Port Perry Pride Celebration. We are happy to see these two organizations grow the event.

For Black History Month, the Affirming committee created a calendar of local events and hosted two speakers for a special Black History Month service. Dr. Leroy Clark and Mrs. Raphael Francis discussed how we must locate the experiences of African Canadian individuals in the context of history, injustice, and oppression.

In February, a small team of congregants from Greenbank United Church participated in the Coldest Night of the Year walk, an event hosted by North House to support unhoused persons in our community.

During the month of March, we participated in PIE Day and Trans Day of Visibility. On March 7, we distributed shepherd's pies made by students from Port Perry High School. The proceeds of this year's fundraiser were split between PFLAG and North Durham Pride, two organizations who support diversity and inclusion in our communities. For Trans Day of Visibility (March 31), members of our congregation and two members of Trinity United Church (Cannington) watched Transforming. We had an excellent discussion afterwards about ongoing problems experienced by the trans community.

In an effort to celebrate Pride, we provided a rock painting tent at the North Durham Port Perry Pride Celebration on June 10. We were joined by friends from Port Perry United Church and the Anglican Church of Ascension. It was great to gather as a group and experience the growth of this excellent event hosted by North Durham Pride and the Township Chamber of Commerce.

For the second Affirming anniversary service for Greenbank United Church, Carolyn Luscombe from Metis Victims Services joined us to safety planning, 2SLGBTQIA+ risk factors, and other important topics. This excellent presentation gave us a lot to reflect on as we continue our affirming work in the community.

On Saturday, November 18, the Affirming committee provided a historical walking tour through Greenbank. A big thank you to Jesse Gillis for his hard work on putting this tour together. Donations provided were given to the roof fund.

I want to thank the members of the committee who contributed to our success this year: Rev. Stephanie Richmond, Mikey Galita, Jesse Gillis, Katie Dwyer, Emmy Iheme and Debbie Watson. We appreciate their time and efforts. On behalf of the committee, I'd like to thank Rev. Stephanie for her leadership and contributions to shaping our affirming mission.

The committee looks forward to more community involvement in 2024, as we work towards creating a more equitable, inclusive community. ## Board of Trustees Report – 2023

The Board of Trustees met five times in 2023.

At the January meeting the Trustees reviewed the United Church of Canada (UCC) insurance program being offered through HUB insurance. The Trustees also reviewed a proposal from the Stewards with respect to the roof replacement. The proposal was approved. The annual 2023 budget was reviewed and approved, as presented by Doug Watson, Treasurer of the Greenbank Church.

At the April meeting Doug Watson advised the Trustees that the UCC insurance program has resulted in a 26.1% reduction in our insurance premium. The Trustees discussed the need for a privacy policy for the church.

A discussion of third party liability insurance through HUB insurance was held at the July

meeting and how that relates to the creation of a rental policy for the church.

At the September meeting a rental agreement for GUC was circulated, dated 2013. A new

rental agreement template will be forthcoming in the new year. The Trustees were made

aware that the Early ON program will be hosted at GUC. The Trustees were in support of this initiative.

The final meeting of the year was held in November to discuss the investment strategy for the upcoming year.

The Trustees would like to thank Doug Watson, Greenbank Church Treasurer, for his guidance and assistance throughout the year.

# Report for the Board of Stewards for 2023

The Greenbank United Church Board of Stewards meet approximately six times per year. Current members are as follows, with their term year ending in brackets: Jim Thomson (2023);Jim Ferguson (2024); Kim Thomson (2025); Mark Puckrin (2026); Ted Smith (2027); and Bill Monkman (2028). Our Treasurer, Doug Watson, also attends each meeting and provides current financial statements. Our Minister also attends these meetings.

Our major project in 2023 was our new Church roof. After many months of meeting with contractors, obtaining estimates and researching and providing our recommendation to the Trustees, The Green Metal Roofing and Manufacturing Company completed the installation of the new roof. We are extremely happy with this company and our roof does look fantastic. Many thanks to Mark Puckrin, who did spend hours working on this project.

A letter was prepared and sent to our Church Family and Community in support of our new roof, and along with some musical fundraising, we are hopeful of raising \$50,000.00. Thanks to all for your continued support!

It was agreed to form a special fundraising group for the Church, including at least 1 Steward. This group would come up with ideas and plan various fundraising events throughout the year. At our congregation meeting, the members of this group are: Debbie Watson, Barb Ward, Joanne Olivero, Mark Puckrin and Kim Thomson. Thank you.

We are exploring an opportunity of a grant to upgrade our Church through a United Church program, called Faithful Footprints, using green energy to try and lessen our carbon footprint. One application only for this grant, which will match every dollar the Church puts up with two dollars, to a maximum of \$20,000 (we put in \$10,000).

The other part of the grant would again match our \$1 with \$2 up to \$10,000. (we pay \$5,000) toward heat pumps or perhaps energy efficient furnaces. Much info and background work is required before the one-time only application is completed. Ted Smith has been in contact with the Faithful Footprints person, and is gathering details (including previous records of heat, hydro, water, etc from Doug), and other info. We are excited about the possibility of this grant, and our wish list includes LED lighting; re-caulking and weather stripping for windows and doors; attic insulation, new efficient ceiling fans; updating electrical panels; kitchen reno; dishwasher, etc.

A maple tree at the front of our Church was storm damaged, and was removed by Brian and Tyson Lee. Thank you! The Stewards decided to obtain and install a flag pole in this location, completed in the spring of 2024.

The EarlyON Program, through the YMCA, is using the Church basement on a weekly basis, for children 0-6, with caregiver, to provide activities and social interaction for the young families in our area. This is a drop in, no registration, no cost to participants. It runs Thursdays from 10 am to 12:30 pm. Please spread the word for this special outreach program! The Stewards look after smoke detectors, light bulbs, yard clean up; purchasing supplies, and all around general upkeep for our Church.

We thank all the Church and Community people who help with grass, snow, flowerbeds, garbage pick up, cleaning (to name a few) and who support our efforts to keep the Church an exciting and active part of our village!
